After careful consideration of the suggestions made by Industries Department in respect of State Reform Action Plan for Ease of Doing Business in the State, the following guidelines are issued for supply of new power connection to Industries requiring initial supply up to 200 KVA.

- 1. The application for supply of electricity connection to Industries will be made on online platform only in order to provide new power connections to industries in a time bound manner. Any functions on offline mode in this respect will be discontinued forthwith. The receipt downloaded from the online system / portal will be a valid acknowledgment of new power connection application. No application shall be made offline.
- 2. The application shall be disposed off within the stipulated timeline after payment of requisite fees. However the applicant shall produce authentic copy of the respective documents on demand by the appropriate authority during inspection/site visit.
- 3. No physical/manual application shall be required to be submitted to the authorities in addition to online application.
- 4. No physical copies of documents which was uploaded by the applicant at the time of submission of online application shall be required.
- 5. The authority shall accept downloaded application form/acknowledgement slip from the portal and shall not require physically signed copy/stamped certificate.
- 6. The applicant shall not be required to meet the authorities in person except in cases where inspection/site visit is mandated by law.
