ADDENDUM

Sub: Deployment of VAWs/ AOs/ HEWs/ HOs/ SCEWs/ SCOs/ LIs to Gram Panchayat Offices

With reference to the Office Memorandum issued with letter no. **AET-MISC-0010/2020-2464** dated **01/02/2020** on the subject - **Deployment of VAWs/ AOs/ HEWs/ HOs/ SCEWs/ SCOs/ LIs to Gram Panchayat Offices**, further clarifications are provided as below:

1. If the total number of extension officers including VAWs/ AOs/ HEWs/ HOs/SCEWs/SCOs/LIs is less than the number of GPs in the block, then the BTMs and ATMs of that block may also be assigned with a GP. Each extension officer/BTM/ATM may be allocated one GP who should be available in the GP office on Monday from 12 noon - 2 pm. In case, the number of officers is still less than the number of GPs then the list of such GPs may be shared with the Director, Agriculture & Food Production.
2. Each block is to maintain a list of reserve officers, who would be extension officers/ BTMs/ ATMs available in the block/district who haven't been allocated any GP. The BAO to make local arrangements within the block in case all extension officers/ BTMs/ ATMs within the block are already assigned GPs, in consultation with CDAO/ADO.
3. In case of emergency work of the department, the extension officer can continue to do the emergency work and not stay in the GP office on Monday from 12 noon - 2 pm. The extension officer shall take prior permission from the respective BAO/AHO/ASCO/BVO of the block.
4. In case Monday is a public holiday then the extension officer may visit the GP office on the next working day from 12 noon - 2 pm.
