The following Block Agriculture Officers (BAO) or Assistant Directors of Agriculture (ADA) are promoted to the rank of Agriculture District Officer (ADO) or Deputy Director of Agriculture (DDA), on adhoc basis in the Pay Scale of Level-13 of Pay Matrix under ORSP Rules, 2017 for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier. This adhoc promotion is subject to concurrence of the OPSC on their earlier adhoc promotion to the rank of ADO/DDA. If the OPSC do not agree to concur the earlier adhoc promotion of any of the following officers, he will be reverted to the lower grades of the cadre.

Such promotion shall be subject to final outcome of the cases in W.P. (C) No. 16909/2016, 16911/2016, 16622/2016 & 16376/2016.
