Functions of SLMC

- The SLMC will implement the guidelines at the State level and provide feedback to National Level Monitoring Committee.
- It will guide and steer the implementation of the scheme in the State
- It will examine and approve the selected list of beneficiaries/projects for inclusion in the scheme in consultation with DLMC
- It will set the targets as per OOMF format and review the progress regularly.

Functions of DLMC

- The DLMC will be the first line of implementation and monitoring system within the overall framework.
- It will identify the beneficiaries, to ensure viability of the project and prepare viable project reports to support the beneficiaries in collaboration with PMU
- It will examine the proposal and recommend to SLMC for consideration
- It will set targets in consultation with SLMC as per OOMF format and monitor the progress closely with the support of PMU
- It will maintain the Dashboard in collaboration with PMU
- It will be responsible for the smooth implementation of the scheme and resolve any issues at the district level. In the process of sorting out implementation issues the Committee would be supported by the district administration wherever required.




