NOTIFICATION


The 2nd component of Krushak Assistance for Livelihood and Income augmentation (KALIA) scheme i.e. Livelihood support to landless agricultural households for livestock & horticultural crop based activities is being taken to further accelerate agricultural prosperity and is being implemented from the year 2018-19 to provide an alternate livelihood to landless agricultural households. Under this component, support is provided for Small goat rearing unit/ Mini Layer Unit/ Dual purpose low input technology birds/ Duckery unit/ Fishery kit/ Bee keeping and Mushroom cultivation to the landless households by way of grant of Rs.12,500/- per family, based on the choice of the household.

The State Cabinet in their 69th meeting held on 22nd February, 2019 have approved that the activities taken under the Second Component under KALIA i.e. Livelihood support for landless agricultural households can be modified from time to time to include/exclude different activities with the concurrence of Government.

Now, two activities i.e. "Dairy Farming" and "Tasar Farming" are included under 2nd component of KALIA scheme i.e. Livelihood support to landless agricultural households.
