The Government of Odisha has constituted Odisha Information Commission to exercise the powers conferred on and to perform the functions assigned thereto under the Right to Information Act, 2005. The powers and functions of State Information Commissioner in the Odisha Information Commission are as per the provisions contained under chapter - V of the Right to Information Act, 2005.

- 2) Applications were invited from intending candidates vide this Department Advertisement No 10257/IPR dated 12.11.2020 for filling up one vacant post of State Information Commissioner in the Odisha Information Commission.
- 3) However, after careful consideration, the Government have decided to invite fresh application from the intending candidates to fill up one vacant post of State Information Commissioner in the Commission as per the following eligibility criteria under the Right to Information Act, 2005 and Right to Information (Amendment) Act, 2019.
- I. The candidates shall be person of eminence in public life with wide knowledge and experience in law, science and technology, social service, management, journalism, mass-media or administration and governance.
- II. The candidates shall not be a Member of Parliament or Member of the Legislature of any State or Union Territory, as the case may be, or hold any other office of profit or connected with any political party or carrying on any business or pursuing any profession. It is clarified that cessation/termination of holding of office of profit, pursuing any profession or carrying any business is a condition precedent to the appointment of a person as State Information Commissioner.
- III. Those already attained the age of 65 years as on the date of issue of this advertisement shall not be eligible to be considered for applying this post.

4) The applicants those who have already applied in response to the aforesaid Advertisement No 10257/IPR dated 12.11.2020 are also required to apply again before the stipulated date line.

The last date for receipt of the application is 3rd January, 2022 by 5.30 PM.

5) The salary, allowances and other terms and conditions of service of the State Information Commissioner shall be governed as per the provisions contained under the Right to Information (Term of Office, Salaries, Allowances and Other Terms and Conditions of Service of Chief Information Commissioner, Information Commissioners in the Central Information Commission, State Chief Information Commissioner and State Information Commissioners in the State Information Commission) Rules, 2019.
