Sri Prafulla Kumar Maharana, Agriculture District Officer, now working as ADO, Pattamundai is promoted to the rank of Chief District Agriculture Officer or Joint Director of Agriculture (JDA), Level-II on adhoc basis in the Pay Scale of Level-13 of Pay Matrix under ORSP Rules, 2017 for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officer, whichever is earlier. This adhoc promotion is subject to concurrence of the OPSC on his earlier adhoc promotion to the rank of ADO/DDA. If the OPSC do not agree to concur his earlier adhoc promotion, he will be reverted to the lower grades of the cadre.

Such promotion shall be subject to final outcome of the cases in W.P. (C) No. 16909/2016, 16911/2016, 16622/2016 & 16376/2016.
