


**Expression of Interest (EOI) for Engagement of Block level Farmer

**Special Programme for "Promotion of Integrated Farming in Tribal
Areas" (SPPIF)**

Expression of Interest (EOI) is invited by the Directorate of Agriculture & Food Production, Odisha, Bhubaneswar from the experienced and interested WSHG Federations/FPOs for engagement as implementation agency at block level for the selected clusters in districts of **Rayagada, Gajapati, Koraput, Mayurbhanj, Bolangir, Kandhamal & Kalahandi** district under the Special Programme for Promotion of Integrated Farming (SPPIF). Interested WSHG Federations/FPOs are required to submit application in sealed envelope superscribed as "**Application for engagement of Block level Implementing Agency for Special Programme for Promotion of Integrated Farming in Tribal Areas (SPPIF)**". Name of Block/Cluster and District should also be mentioned on the envelope. Filled application in the prescribed format should be enclosed and sent by registered/speed post. Submission through e-mail/courier will not be entertained in this regard. The EOI should be addressed to Office of the Chief District Agriculture Officer cum Project Director ATMA of respective District. Last date for receipt of proposal is 15/03/2022 upto 1.00pm and the same shall be opened on the same day at 3.30pm. in the presence of authorized signatory and representatives. Special Programme for "Promotion of Integrated Farming in Tribal Areas" (SPPIF)

Department of Agriculture & Farmers' Empowerment, Government of Odisha extended the Special Programme for Promotion of Integrated Farming-SPPIF to 8 districts of Odisha with focus on comprehensive development of agriculture, animal husbandry and fishery sectors in the district through technology diffusion, establishment of community level institutions, management of natural resources and use of organic inputs in integrated approach.

The Objective of SPPIF

1. Optimum utilisation of available natural resource through principles of Reduce, Recycle, Reuse & Recovery.
2. Promotion of site specific and landscape-based farming system through diversification, intensification, and integration in cluster approach.
3. To improve livelihoods and income of farmers through enterprises, marketing, and value chain interventions by WSHGs/FPOs.

Cluster Approach

SPPIF shall be implemented in a cluster approach with clusters being a number of contiguous patches of 100 Ha each. 250 Ha shall be covered in 2-3 patches in a GP where at least 600 HHs shall be covered. Scale of the programme is mentioned below. Within the clusters, integration of different production systems such as Agriculture, Horticulture, Livestock, Fisheries, Agro forestry shall be done through integration of different schemes.

Key features of SPPIF are protective irrigation, promotion of improved agronomic practices, crop diversification and intercropping, soil health management, custom hiring centers to reduce drudgery, community managed seed systems, promotion of vegetable cultivation for nutrition security, streamlining vaccination systems, Goat Shelter and poultry night shelter development, breed farms of indigenous birds, localized production of suitable fingerlings/yearlings, promotion of FPOs, etc. with "farmer to farmer" learning forming core implementation strategy.

List of blocks for application under EoI for SPPIF

Directorate of Agriculture & Food Production (DA&FP) is inviting eligible WSHG Federations/FPOs to apply for role of implementation agency under SPPIF. One WSHG Federation/FPO shall be selected as implementation for one Block/Cluster covering 10 GPs. List of blocks are as follows: -

The Eligibility Criteria of the WSHG Federations/FPOs are mentioned below:

1. WSHGs Federations/FPOs should be legally registered or recognised by any govt agency.
2. For FPOs, FPOs registered under Cooperative Act or Company Act. WSHG Federations should receive recommendation letter from Mission Shakti Dept.
3. Should provide a self-attested copy of registration, PAN number and self-attested copy of PAN card.
4. WSHG Federations/FPOs should be operational for at least one year.
5. WSHG Federations/FPO should have annual financial reports submitted to the concerned regulatory authorities. If FPO is registered under company act must have filed all the compliance as per company act, 2013.
6. WSHG Federations/FPO must not have defaulted loans from any governmental or non-governmental sources such as OLM, OTELP, NABARD, Micro finance etc.
7. WSHG Federations/FPO should have BODs/CEOs/President/Others who must have minimum literacy skills. Signatories of the WSHG Federations/FPO must possess reading and writing skills in Odia. Reading and writing skills in Hindi and English will be considered added advantage. They should be able to sign on the bank passbook.
8. WSHG Federations/FPO must have history of conducting regular meetings with preparation of documented minutes. WSHG Federations/FPO meetings should have happened at least once in every quarter.
9. Should not have more than one-third of the Governing Body members related to each other and no staff members related to each other should be supervising each other.
10. WSHG Federations/FPOs with experience of working with government program in the proposed block.

The format of Eol is in Annexure-A and WSHG Federations/FPOs need to apply in the specified format only. Copies of the following documents need to be submitted along with the Eol form:

- Registration certificate.
- Previous years audited statement of accounts up to 3 yrs.

- Fixed asset position including its present value and location.
- PAN and Aadhar of Chief Executive Officer/President and Board Members including address of head and field offices.
- MoU/ agreement/ any documentary evidence of working for Govt. or special projects or Govt. undertakings of implementing the programme of last five years only

Office of the Chief District Agriculture Officer(CDAO) Mayurbhanja/ Bolangir/ Kandhamal/ Kalahandi/Rayagada/Koraput/Gajapati.

Process of Selection:

- **Stage 1:** Shortlisting of applications from the received applications after desk assessment by District Level Committee. Scrutiny committee shall consist of representatives from office of CDAO, CDVO, DDH, DFO and SPA (WASSAN). Any other representatives nominated by the office of CDAO cum PD ATMA.
- **Stage 2:** Presentations by shortlisted organizations before "Selection Committee under chairpersonship of Collector & District Magistrate or appointed representative". Members of selection committee shall consist of representatives from office of DRDA, DSWO, ITDA, CDAO cum PD ATMA, CDVO, DDH, DFO and SPA (WASSAN). Any other representatives nominated by the Collector & District Administration. This will be followed by a field visit by a selection committee. Selection committee will be divided into task teams for field visit for different blocks.
- **Stage 3:** One FPO per cluster/Block will be selected as Implementing Agency for the Block by the committee through presentation and field visit. Selected FPO/WSHG Federation will be approved by the Collector & District Magistrate.
- **Stage 4:** FPO/WSHG Federation selected as Implementing Agency will submit all relevant documents for verification.
- **Stage 5:** After completion of selection of FPO, MoA will be signed between CDAO cum ATMA, Facilitating Agency and selected FPO/WSHG Federation for the Project.

P:S: Any procedural changes can be made in the process of selection as per local situations with approval of Collector & District Magistrate of the district.
