Expression of Interest for "Special Programme for Promotion of Integrated Farming in Odisha"

Department of Agriculture & Farmers' Empowerment, Government of Odisha is implementing a "Special Programme for promotion of Integrated Farming in Odisha" for the last 4 years in Malkangiri District with focus on comprehensive development of Agriculture, Horticulture, Livestock and Fishery sectors in the district in convergent mode through technology diffusion, establishment of community level institutions, integrated management of natural resources and use of organic inputs. Government of Odisha then extended this scheme to 4 more districts in pilot mode. Now the State Government is now extending this scheme to 4 more districts. Key features of SPPIF are protective irrigation, promotion of improved agronomic practices, crop diversification and intercropping, soil health management, custom hiring centres to reduce drudgery, community managed seed systems, promotion of vegetable cultivation for nutrition security, streamlining vaccination systems, Goat Shelter and poultry night shelter development, breed farms of indigenous birds, localized production of suitable fingerlings/yearlings, promotion of FPOs, etc. with farmer to farmer learning forming core implementation strategy.

Major Objective of the Programme

- 1. Securing crops through protective irrigation for mitigating dry spells.
- 2. Promotion of crop diversification through intercropping, poly-cropping, crop rotation, and Adarsha Bagicha initiative.
- 3. Establishing the community managed seed systems to meet the diverse seed needs of farmers.
- 4. Taking up soil health management activities for rejuvenation of soils.
- 5. Documentation and evaluation of local landraces through Participatory varietal trials.
- 6. Promotion of vegetable cultivation at the household level for nutritional security and intensive clusters for income security.
- 7. Establishment of preventive health care systems for livestock to reduce mortality.
- 8. Promotion of desi poultry through breed farms and appropriate support systems.
- 9. Promotion of Goatery through shed construction and appropriate support systems.
- 10. Documentation and registration of indigenous livestock breeds.
- 11. Realizing fisheries potential in water bodies (seasonal and perennial) in numerous water bodies with seasonal and perennial water storage
- 12. Promotion of aggregation, processing, value addition and marketing of products of different production systems through farmer producer organisation.
- 13. Convergence with MGNREGA for NRM activities.

In accordance with approval from competent authority, Directorate of Agriculture & Food Production (DA&FP) is inviting eligible Non-Governmental Organisations (NGOs) for the role of "Facilitating Agencies (FA)". Selection will be done by district level committee under chairmanship of Collector and District Magistrate.

The Mandatory criteria of the NGO to be selected as FA are mentioned below:

- 1. Should be legally registered as Society/Trust..
- 2. Should provide a self-attested copy of registration, PAN number and self-attested copy of PAN card.
- Should not have been blacklisted by Government of India, State Government of Odisha, other government agencies and any Indian or international donor and provide a selfdeclaration by the authorized representative to this effect.

- 4. Should have a minimum of 3 years of work experience in the proposed blocks on Rainfed Agriculture production systems. Such experience may include soil and water conservation, crop diversification, climate resilient cropping system, horticulture, agroforestry, livestock husbandry and rangeland management, capacity building of community organizations and/or farmer producer's organizations.
- 5. Should have last 3 years' audited Balance Sheet and Financial Reports submitted to the concerned regulatory authorities.
- 6. The chief functionary should not be a formal member of any political party and furnish an undertaking to this effect.
- 7. Should not have more than one-third of the Governing Body members related to each other and no staff members related to each other should be supervising each other.
- Must have worked with any of the government program related to agriculture, NRM, farmer's organization in a substantial way. (Not merely in awareness or training or market linkages).
- 9. One NGO is eligible for applying for one cluster only.

The format of Eol is in Annexure-A and NGOs need to apply in the specified format only and the copies of the following documents need to be submitted along with the Eol form:

- (i) Registration certificate of NGO.
- (ii) Previous 3 years Audited statement of accounts for 2018/19, 2019/20, 2020/21
- (iii) Previous 3 years Annual Report 2018/19, 2019/20, 2020/21.
- (iv) Fixed asset position including its present value and location.
- (v) Profile of professional staff of the organization.
- (vi) MoU/ agreement/ any documentary evidence of working for Govt. or special projects or Govt. undertakings for implementing drought resilient agriculture activities of last three years only.
- (vii)Address of head and field offices.

Process of Selection:

• Stage 1: Short listing of at least three applications from the received applications after desk assessment by Screening Committee.

• **Stage 2:** Presentations by shortlisted organizations before "District Committee under chairpersonship of Collector & District Magistrate or appointed representative". This will be followed by a field visit by a selection committee.

• **Stage 3:** One NGO and FPO per cluster in a block will be selected as Facilitation Agency (FA) for the Block by the committee through presentation and field visit. Selected FA will be approved by the Collector & District Magistrate.

• **Stage 4:** NGOs and FPOs selected as FAs and implementing agencies will submit all relevant documents for verification.

• **Stage 5:** After completion of selection of FA, MoU will be signed between ATMA, Programme Secretariat and selected NGOs for the Project.
