The cover should be prominently superscripted with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE".

The intending bidders should drop their quotations in the box located at the Department premises, Sports & Youth Services Department during the office hours on or before the scheduled date and time. The quotation received by Post/Speed Post/Registered Post/Courier or otherwise will not be received after due date and time. The tenders received shall be opened on the same day i.e. on 31.01.2022 at 4:00 P.M. in the Office Chamber of Joint Secretary to Government (O.E.), Sports & Youth Services Department in presence of tenderers or their authorized agents. If this day is declared as a Government holiday, the tenders will be received and opened on the next working day as per the scheduled time.

4. The Vehicle will be available in the premises of Sports & Youth Services Department for inspection during the official working days between 11:00 A.M. to 4:00 P.M. (time duration) from 10.01.2022 to 31.01.2022.

5. The Auction Sale will be governed by the following terms and conditions:

- I. The bidder is required to pay earnest money of Rs.2,000/- with the sealed quotation.
- II. Earnest money is payable by means of Demand Draft drawn in favour of "DDO-cum-Under Secretary to Government, Sports & Youth Services Department payable at HDFC Bank, Nayapalli" or by cash in the Accounts Section of this Department.
- III. Quotations received without demand draft or non-deposit of earnest money in Accounts Section before the due time will not be considered as valid and shall not be accepted.
- IV. Successful bidder will be required to deposit full bid amount by means of Demand Draft drawn in favour of "DDO-cum-Under Secretary to Government, Sports & Youth Services

Department payable at HDFC Bank, Nayapalli or in cash the same day or the next day positively otherwise the bid will be cancelled.

- V. The earnest Money of the successful bidder will be adjusted during deposit of the total bid amount. If they fail to deposit the same, the earnest money deposited in cash or bank draft will be forfeited.
- VI. During the delivery of the sold vehicle, the successful bidder will submit their original identification document/ residential proof (Aadhar card/ Voter Id Card/ PAN Card/ Driving License).
