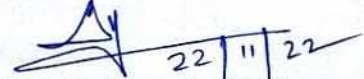

Sri Dussasan Praharaj, Joint Director of Agriculture (Level-I), now working as JDA (Information), DA & FP (O), BBSR is promoted to the rank of Additional Director of Agriculture (Superior Grade) in the Pay Scale of Level-15 of Pay Matrix under ORSP Rules, 2017 on adhoc basis for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officer, whichever is earlier. This adhoc promotion is subject to concurrence of the OPSC on his earlier adhoc promotion to the rank of JDA, L-I. If the OPSC do not agree to concur his earlier adhoc promotion, he will be reverted to the lower grade of the cadre.

Such promotion shall be subject to final outcome of the cases in W.P. (C) No. 16909/2016, 16911/2016, 16622/2016 & 16376/2016.

On promotion to the rank of Additional Director of Agriculture (Superior Grade), Sri Praharaj is posted as Director, IMAGE, Bhubaneswar against existing vacancy with immediate effect.

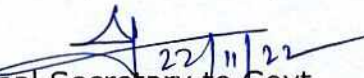
