Sub: Constitution of Single Window Committee for implementation of Odisha Renewable Energy Policy, 2022.

The Odisha Renewable Energy Policy, 2022 was notified on 30.11.2022 vide Odisha Gazette notification No. 11757-ENG-HYD-HYDRO-0009/2022/En. to promote development of renewable energy projects in the state and to accelerate adoption of clean energy.

2. Subsequently, this Department vide Notification No. 12284 dated 15.12.2022, has designated GRIDCO Limited as the Nodal Agency as per Para 25.2 of the said policy.

3. Para 25.5 of the policy stipulates that a Single Window Committee (SWC) shall be constituted under the chairmanship of Principal Secretary / Secretary, Department of Energy to discharge various responsibilities as enumerated therein.

4. Accordingly, the Single Window Committee is hereby constituted as follows:

- Nominee of Revenue and Disaster Management  
Department not below rank of Additional Secretary : Member
- CEO of concerned DISCOM : Member
- Director, GRIDCO : Member Convener

The SWC may invite official from any Department / PSU or expert, as may be required.

GRIDCO, the Nodal Agency, shall provide secretarial assistance / support to the Single Window Committee.
