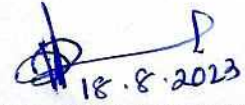

Sri Sandip Kumar Sahoo, CDAO now working as CDAO, Malkangiri is promoted to the rank of Joint Director of Agriculture, Level-I (Super time Scale) in the Pay Scale of Level-14 of Pay Matrix under ORSP Rules, 2017 on ad-hoc basis for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officer, whichever is earlier.
