The following Block Agriculture Officers (BAOs) are promoted to the rank of Agriculture District Officer (ADO) / Deputy Director of Agriculture (DDA), on ad-hoc basis in the Pay Scale of Level-13 of Pay Matrix under ORSP Rules, 2017 for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier. This ad-hoc promotion is subject to concurrence of the OPSC on their earlier ad-hoc promotion to the rank of BAO/ADA. If the OPSC do not agree to concur the earlier ad-hoc promotion of any of the following officers, he will be reverted to the lower grade of the cadre.

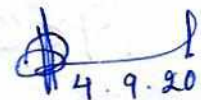
