NOTIFICATION

In exercise of the powers conferred by sub-section (1) read with sub-section(2) of section 87 of the Odisha Excise Act , 2008 (Odisha Act 10 of 2013) and in supersession of the notification of the State Government in the Excise Department No. EXC-POL-POL-0006-2021-3578 dated the 17th May,2023 published in the Odisha Gazette No. 1124 dated the 18th May, 2023, the State Government in consultation with the Chief Justice of the Orissa High Court do hereby re-constitute the following Special Courts for the areas specified in column(3) of the Schedule given below which shall be presided by the Officer mentioned against each in column (2) for trial of offences under the said Act, except the offences which are punishable with imprisonment for three years or which may extend to seven years and fine which shall not be less than ten thousand rupees and may extend up to fifty thousand rupees.
