The following Chief District Agriculture Officers (CDAOs) / Joint Directors of Agriculture (JDAs), Level-II are promoted to the rank of Joint Director of Agriculture, Level-I (Super Time Scale) in the Pay Scale of Level-14 of Pay Matrix under ORSP Rules, 2017 on an ad-hoc basis for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier. These ad-hoc promotions are subject to the concurrence of the OPSC on their earlier ad-hoc promotion to the rank of CDAO/JDA-II. If the OPSC do not agree to concur with their earlier ad-hoc promotion, they will be reverted to the lower grade of the cadre.

Such promotion shall be subject to the outcome of W.P(C) Nos. 16909/2016, 16911/2016, 16622/2016 & 16376/2016 and other related cases, if any.
