The following Chief District Agriculture Officers (CDAOs) / Joint Directors of Agriculture (JDAs), Level-II are promoted to the rank of Joint Director of Agriculture, Level-I (Super time Scale) in the Pay Scale of Level-14 of Pay Matrix under ORSP Rules, 2017 on adhoc basis for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier. These adhoc promotions are subject to concurrence of the OPSC on their earlier adhoc promotion to the rank of CDAO/JDA-II. If the OPSC do not agree to concur their earlier adhoc promotion, they will be reverted to the lower grade of the cadre.

Such promotion shall be subject to final outcome of W.P(C) Nos. 16909/2016, 16911/2016, 16622/2016 & 16376/2016 and other related cases, if any.
