The following Block Agriculture Officers (BAOs) / Assistant Directors of Agriculture (ADAs) are promoted to the rank of Agriculture District Officer (ADO) / Deputy Director of Agriculture (DDA) on ad-hoc basis in the Pay Scale of Level-13 of Pay Matrix under ORSP Rules, 2017 for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier. This ad-hoc promotion is subject to concurrence of the OPSC on their earlier ad-hoc promotion to the rank of BAO/ADA. If the OPSC do not agree to concur the earlier ad-hoc promotion of any of the following officers, he will be reverted to the lower grade of the cadre.

Such promotion shall be subject to final outcome of WP(C) Nos.16909/2016, 16911/2016, 16622/2016, 16376/2016 & other related cases pending in Hon'ble Court, if any.
