
Madam/Sir,

With reference to the above-cited letter on the subject: Modified Standard Operating Procedure for conducting creation of Farmer Registry database, it is to inform that there has been certain changes made to a point 3.2.3 pertaining to NMS score less than 10% and 3.5.1.c.iv pertaining to creation of User Ids in the previously issued Standard Operating Procedure (SOP).

As per the new instructions,

1. The applications with NMS score less than 10% would not be submitted in the portal.
2. Tehsildars would ensure creation of User Ids for Revenue Inspectors (Verifier 1) and operators (base level staff of Agriculture and Allied staff) in consultation with concerned BAO/AAO using the Verifier 2 User Ids created for them.




