No. DAFE-AFE-FE-0041-2024- 11502 /Ag.&FE, Dated- 13-05-2025

The following Agriculture District Officers (ADOs) /Deputy Directors of Agriculture (DDAs) are promoted to the rank of Chief District Agriculture Officer (CDAO)/ Joint Director of Agriculture (JDA), Level-II on ad-hoc basis in the Pay Scale of Level-13 of Pay Matrix under ORSP Rules, 2017 for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier. These ad-hoc promotions are subject to concurrence of the OPSC on their earlier ad-hoc promotion to the rank of ADO/DDA. If the OPSC do not agree to concur the earlier ad-hoc promotion of any of the following officers, they will be reverted to the lower grade of the cadre.

Such promotion shall be subject to final outcome of W.P(C) Nos.16909/2016, 16911/2016, 16622/2016, 16376/2016 & WP(C) No.2076/2024 and other related cases pending in Hon'ble Court, if any.

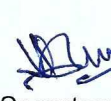

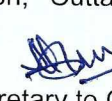

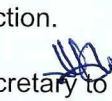
