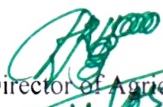

There are other entities and co-operative societies with majority shareholding from the Government of India that are also actively engaged in similar project execution and have the necessary capability. Such entities are currently not covered under the clause. Including entities and co-operative societies with majority shareholding from Government of India will bring in more qualified bidders while still ensuring that only government-linked and credible entities are considered, leading to more competitive outcomes for the dept. It is requested that the dept. ask for – “The bidder must be either a Central Public Sector Undertaking or a Govt. PSU or a cooperative society with major shareholding (greater than 50%) held by Govt. of India to carry out I.T related activities. Supporting Documents Required: Copy of certificate of Incorporation / Registration”	Bid condition prevails
2	Point 12.2.1, Sl. No. 20, Page No. 15	Camera: 48Mega-Pixel, top-mounted	The dept. has asked for a 48 MP top-mounted camera. However, in most IFPs, cameras are provided in-built within the panel and are positioned at the top. There is no functional difference between a top-mounted and an in-built top-positioned camera in terms of usage. Restricting the specification only to “top-mounted” may lead to exclusion of OEMs offering in-built cameras despite meeting the required performance. It is requested that the dept. ask for – “Camera: 48Mega-Pixel, top-mounted/ in-built”	Refer Corrigendum

No. 27, Page No. 16	Built-in Whiteboard software in Android: AI Powered Whiteboard, Handwriting recognition of all content like English, Odia, Mathematical, chemical equations and any kind of question which can be easily answered with the help of AI.	The requirement of an AI-powered whiteboard along with advanced handwriting recognition for multiple languages and subjects is not a standard feature available across most IFP OEMs. Such highly specific functionality unnecessarily restricts fair competition from capable OEMs. It is requested that the dept. to kindly remove the clause.	Bid condition prevails
4	Point 12.2.1, Sl. No. 23, Page No. 15	Patch Update: The OEM should update the patch with latest OS for 3 Years.	The dept. has asked OEMs to provide patch updates with the latest OS for 3 years. Unlike OEMs of smartphones or tablets, IFP OEMs do not usually provide regular OS upgrades or long-term patch update support. It is requested that the dept. to kindly remove the clause.	Bid condition prevails
5	Point 12.2.1, Sl. No. 19, Page No. 15	Microphone: 6-microphones array (Pickup radius: 8m) or higher	The dept. has specified both the number of microphones and pickup radius. But pickup radius is not a standard parameter and most OEMs do not specify pickup range in their product catalogues. Keeping such a condition may unnecessarily restrict participation, even when OEMs provide adequate audio performance. It is requested that the dept. ask for – “Microphone: 6-microphones array or higher”	Bid condition prevails
6	Point 12.2.1, Sl. No. 34, Page No. 16	Anti-virus (AV) Software for 3 years: AV Solution must be MII-compliant with AV-Test certification and a local support office in Odisha. Features: Vulnerability Scan, Anti-Ransomware, Custom Backup/Restore (custom extensions), Application Control, Patch & Asset Management, OTP based USB Access, Tuneup, Safe Mode Protection	The dept. has asked for antivirus software with multiple advanced features along with specific certifications and local support conditions. As per our understanding, bidders are allowed to offer antivirus from third-party vendors. It is requested that the dept. kindly clarify the same.	Bid condition prevails

	Point No. 6, Page No. 11	Validity of the Bid: The technical bid and price bid validity should be for a minimum period of 180 days . The bidder should be ready to extend the validity, if required.	A bid validity period of 180 days is very long considering current market conditions where prices and stock availability are dynamic. It is difficult for bidders to hold pricing for such a long duration, which may either discourage participation or lead to inflated pricing to cover associated risks. It is requested that the dept. ask for – “Validity of the Bid: The technical bid and price bid validity should be for a minimum period of 30 days. The bidder should be ready to extend the validity, if required.” ✓	Bid condition prevails
8	Point No. 7(i) Page No. 11	The concerned authority reserves the right to verify information submitted and inspect the manufacturer’s facilities , if required, to confirm their capabilities.	The dept. has asked for inspection at OEM manufacturing facilities. None of the OEMs permit inspection at their manufacturing units as it is against their internal policies. So, buyer depts. usually conduct inspection at the bidder’s warehouse or delivery location. It is requested that the dept. ask for – “The concerned authority reserves the right to verify information submitted and inspect the bidder’s warehouse, if required, to confirm their capabilities.” ✓	Refer Corrigendum

The current delivery timeline of 90 days is not sufficient considering the requirement of supply, installation, and commissioning across 314 locations. Such large-scale deployment requires adequate time for proper execution, logistics, and coordination at the field level. It is requested that the dept. ask for – “Delivery Schedule – Estimated time for delivery of Interactive Panels after order confirmation. 314 no.of Interactive Panels should be delivered and installed within 120 days of the receiving of Purchase order /LoA/ Work order at the 314 FIACs in block level.”	Refer Corrigendum

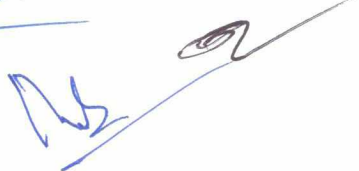
